Heathfield Park Neighbourhood Plan Information Statement

A Referendum relating to the adoption of the Heathfield Park Neighbourhood Plan will be held on Thursday 17th July 2014.

The question which will be asked in the Referendum is 'Do you want Wolverhampton City Council to use the Neighbourhood Plan for Heathfield Park to help it decide planning applications in the Neighbourhood area?'

The Referendum area is identified on the map which is included with this information statement. The Referendum area has been amended by the Examiner during the examination of the neighbourhood plan.

A person is entitled to vote in the Referendum if on 9th June 2014:-

- He or she is entitled to vote in an election of any Councillor of Wolverhampton City Council whose area is in the Referendum area; and
- His or her qualifying address for the election is in the Referendum area. A person's
 qualifying address is, in relation to a person registered in the register of electors, the
 address in respect of which he or she is entitled to be so registered.

The Referendum expenses limit that will apply in relation to the Referendum is £2,682.78. The number of persons entitled to vote in the Referendum by reference to which that limit has been calculated is 5,437.

The Referendum will be conducted in accordance with procedures which are similar to those used at local government elections.
