Request:

I am writing to you under the Freedom of Information Act 2000 to request the following information from Wolverhampton Adult Social Care Services:

- All assessment documents currently used by social workers.
 In response to question 1, please see information attached provided from page 2.
- Any reports or documents related to foot health & care services.
 In response to question 2, Section 1 of the Freedom of Information Act 2000 places two duties on public authorities. Unless exemptions apply, the first duty at:
 - Section 1(1) (a) is to confirm or deny whether the information specified in a request is held.
 - The second duty at Section 1(1)(b) is to disclose information that has been confirmed as being held.

In respect of question 2, it has been established after careful consideration that the Council does not hold the above information as we do not provide the above service.

Consequently, we are unable to provide any information relating to the above, and are informing you as required by Section 1(1) (a) of the Act, that states:
