

**THE WOLVERHAMPTON CITY COUNCIL (SUNNYSIDE, INKERMANS GROVE)**  
**COMPULSORY PURCHASE ORDER 2021**

Wolverhampton City Council (in this Order called "the Acquiring Authority") hereby make the following Order:-

1. Subject to the provisions of this Order, the Acquiring Authority is under the Housing Act 1985 Section 17 hereby authorised to purchase compulsorily the land described in paragraph 2 for the purpose of the provision of housing accommodation
  
2. The land authorised to be purchased compulsorily under this Order is the land described in the Schedule and delineated and shown coloured pink on a map prepared in duplicate, sealed with the common seal of the acquiring authority and marked "Map referred to in The Wolverhampton City Council (Sunnyside, Inkerman Grove) Compulsory Purchase Order 2021"

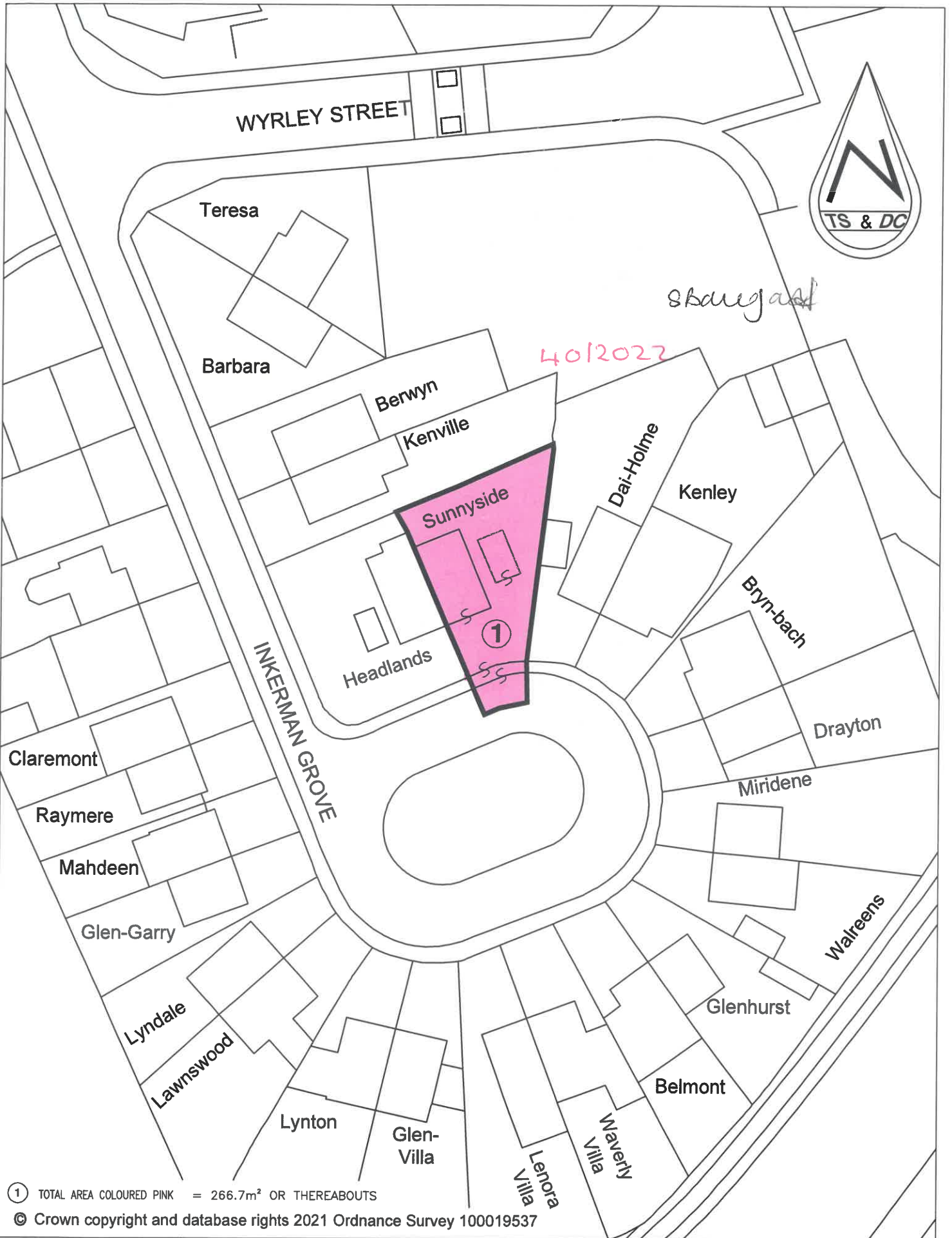
