

# Description of Street Trading Consents

**Annual street trading consents may run from 1 April until 31 March the following year. Consents can be applied for part way through the year, but they will only run until 31 March. An annual consent will not be granted for periods of less than four weeks.**

## **A Consents**

Locations allocated to trade within the Wolverhampton City Centre ring road.

The annual consent permits trade Monday to Sunday 07:00 until 18:00 hours (until 21:00 hours during Christmas Late Night Shopping).

## **AB Consents**

Locations allocated to trade in Bilston Town Centre.

The annual consent permits trade Monday to Sunday 07:00 hours until 18:00 hours (until 21:00 hours during Christmas Late Night Shopping).

## **AF Consents**

Locations allocated to trade on the highway around the Molineux Football Stadium.

The annual consent permits trade on match days only.

## **AW Consents**

Locations allocated to trade High Street, Wednesfield.

The annual consent permits trade Monday to Sunday 07:00 hours until 18:00 hours (until 21:00 hours during Christmas Late Night Shopping).

## **AE Consent**

Locations allocated to evening consents.

The annual consent permits trade Monday to Sunday 20:00 hours until 06:00 hours.

However, if these consent holders sell food and drink after 23:00 hours, they will require a premises licence under the Licensing Act 2003 which will relate to a specific premise and location.

## **B Consent**

The issuing of B Consents will be restricted to applicants whose typical purpose is the sale of ice-cream or snacks by means of a mobile unit.

The consent permits trading Monday to Sunday 08:00 hours until 20:00 hours.

No trading is permitted in any area within a  $\frac{3}{4}$  mile radius of any Wolverhampton City Council market.

No trading is permitted within 50 metres of:

- any entrance or exit to an educational establishment
- any retail shop or unit
- any religious premise or building; or
- any licensed premises

Not more than one consent holder is permitted to trade in particular street at any given time.

No trader may remain static for more than 60 minutes in one location and must not return to the location within two hours

This consent is not valid within the perimeter of any Council Park, Recreation Ground or Open Space.

## **CF Consent** - Food - Other City Areas

The consent permits trading Monday to Sunday 06:00 hours until 20:00 hours

## **CFL Consent** - Flowers - Other City Areas

The consent permits trading Monday to Sunday 06:00 hours until 20:00 hours

## **PL Consent** – Private Land (Food and Non Food)

The consent permits trading on private land.

## **PLM Consent** – Private Land Molineux Match Days

The consent permits trading on private land on match days only.

## **Temporary / Occasional Consents**

This type of consent will last for one trading day, for a particular pitch in Wolverhampton and permits trading 08:00 hours until 18:00 hours. No more than 30 consents will be issued per pitch, per trader, per financial year.

## **Promotional Space Consents**

All promotions and activities must take place in the specified promotional space and permits promotional activities only, usually between the hours of 08:30 hours until 17:00 hours.
