

# PUBLIC NOTICE

**THE WOLVERHAMPTON CITY COUNCIL**  
**(KING CORONATION STREET PARTIES)**  
**(TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2023**

**NOTICE IS HEREBY GIVEN** that the Wolverhampton City Council propose to make an Order under Section 21 of the Town Police Clauses Act 1847, prohibiting vehicles from proceeding on the following stretches of road on the dates specified below:

**Saturday 6 May 2023**

Ashbourne Road – Closed its entire length.

Barn Farm Close – Closed its entire length.

Birches Barn Avenue – Closed its entire length.

Churchfield Road – Closed between its junctions with Beech Road and Eccleshall Avenue. The vehicular diversion route is: Beech Road, Eccleshall Avenue and vice versa.

Dickinson Avenue – Closed in both direction between its junctions with Whitgreave Avenue/Leacroft Avenue and Low Hill Crescent. The vehicular diversion route is: Leacroft Avenue, Hammond Avenue.

Janine Avenue – Closed its entire length.

Reliance Place – Closed its entire length.

Springhill Avenue – Closed between its junctions with Foxhills Road and Springhill Grove. The vehicular diversion route is: Hilston Avenue, Warstones Road, Springhill Lane and vice versa.

Tithe Road – Closed from its junction with Hampstead Close to end of Cul-de-Sac.

Whetstone Road – Closed its entire length.

Walter Road – Closed from outside properties 19 & 20 to its junction with Martin Road.

Windmill Crescent – Closed between its junctions with Wood Bank Road and Chelmarsh Avenue.

**Sunday 7 May 2023**

Balmain Crescent – Closed its entire length.

Church Hill Road – Closed in both directions between its junctions with Clifton Road and Lloyd Road. The vehicular diversion route is: Lloyd Road, Stockwell Road, Clifton Road and vice versa.

Church Walk – Closed between its junctions with Birches Barn Avenue and Saint Phillips Grove.

Cromwell Road – Closed in both directions from outside properties 53-57/56-58b. The vehicular diversion route is: Cavalier Circus and vice versa.

Denham Gardens – Closed in both directions between properties.

Dewsbury Drive – Closed from its junction with Sandhurst Drive to outside property 50. The vehicular diversion route is: Sandhurst Drive, Mount Road, Links Road and vice versa.

Elm Farm Road – Closed its entire length.

Helming Drive – Closed from outside properties 160 & 125 to outside properties 175 & 135.

Jeffrey Avenue – Closed its entire length.

Leicester Street – Closed in both directions between its junctions with Dunstall Road and Gloucester Street. The vehicular diversion route is: Dunstall Road, Gloucester Street and vice versa.

Newbridge Gardens – Closed its entire length.

Renton Road – Closed between its junctions with Sheldon Road and Elmdon Road. The vehicular diversion route is: Sheldon Road, Elmdon Road and vice versa.

Rocester Avenue – Service Road only closed between properties 21 to 27.

Station Road – Closed between its junctions with Brook Street and Warwick Street. The vehicular diversion route is: Brook Street, Temple Street, Warwick Street and vice versa.

Vicarage Road, Wednesfield – Closed between its junctions with Nordley Road and School Road. The vehicular diversion route is: Nordley Road, Woden Avenue, School Road and vice versa.

Wakeley Hill – Closed between its junctions with Butts Road and Swan Bank. The vehicular diversion route is: Swan Bank, Manor Road, Penn Road, Church Hill and vice versa.

**Monday 8 May 2023**

Copthorne Road – Closed its entire length. The vehicular diversion route is: Lea Road, Stubbs Road, Penn Road and vice versa.

Elton Close – Closed its entire length.

Hartshorn Street – closed its entire length.

Taunton Avenue – Closed from junction Springfield Lane to junction Fontwell Road. The vehicular diversion route is: Redcar Road, Fontwell Road, Springfield Lane and vice versa.
