## Child Protection External Spend

### Request:

For each financial year, 2013/14 and 2014/15 please let me know, with regard to children who are considered to be or to potentially be in need of help or protection:

1. Which expert witness firms/agencies were used and how much was spent with each one;

With reference to question 1, I can confirm that the Council holds information falling within the description specified in your request. Unfortunately, we are unable to provide this information to you as we believe that S12 of the Freedom of Information Act 2000 to be engaged.

Section 12 of the Act allows a public authority to refuse a request if the cost of providing the information to the applicant would exceed the 'appropriate limit' as defined by the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004. The information you have requested is not currently held in a format that can be readily accessible as it is information that needs to be manually extracted from some 300 paper files. As a result we believe that the exemption is engaged.

The Regulations provide that the appropriate limit to be applied to requests received by local authorities is £450 (equivalent to 2.5 days of work). In estimating the cost of complying with a request for information, an authority can only take into account any reasonable costs incurred in:

- "(a) determining whether it holds the information,
- (b) locating the information, or a document which may contain the information,
- (c) retrieving the information, or a document which may contain the information, and
- (d) extracting the information from a document containing it".

For the purposes of the estimate the costs of performing these activities should be estimated at a rate of £25 per hour.

As such I believe that the aggregated time that it would take to manually extract and collate the information would be in excess of 18 hours (equivalent to a notional cost of £450).

2. Which firms/agencies were used to provide assessments of parents or individuals applying for special guardianship orders (including residential/viability/community assessments) and how much was spent with each one;

We do not use firms/agencies to provide this service. It is provided in-house.

We have used Heantun Child Care to provide support services to foster carers. The total was £65k for 2014-15.
