Request:

This is a request under the Freedom of Information Act.

Please could you let me know, for calendar year 2014 and 2015 (to date):

- a) The number of care/nursing/residential homes to which the authority has suspended or cancelled admissions in this period;
- b) The name of each home and its operator/provider with whom the contract is held;
- c) The date at which each suspension started and finished (if it has not finished please state that it is ongoing)
- d) If the contract has been cancelled please state the date of cancellation
- e) The reason for the suspension/cancellation
- f) Please indicate for each suspension/cancellation whether it was made public by the authority.

Response:

In respect of the information identifying care homes and providers has been withheld

The Council considers that the information you have requested, which we have Identified above, is exempt from disclosure under Section 43 of the Freedom of Information Act. Section 43 of the Act permits the Council to withhold information if its disclosure would, or would be likely to, prejudice the commercial interests of any person, including the public authority holding it.

We should explain that Section 43 of the Freedom of Information Act 2000 permits the Council to withhold information if its disclosure would, or would be likely to, prejudice the commercial interest of any person, including the Public Authority holding it. The Council considers that to disclose the information you have requested, at this stage, would prejudice the commercial interests of the parties mentioned above and this information is therefore exempt from disclosure under section 43 of the Act.

This information is commercially sensitive to the tenderers and it is important to their competitiveness that they are able to remain as a participant in the market. When considering public interest for and against disclosure of this requested information, the Council considers that the public interest in withholding the information from disclosure to the wider world outweighs the public interest in disclosure. This is because in all cases, people using the service and families of people using the service are always informed if a service is suspended and residents are therefore appropriately safeguarded. The Council however considers that taking historical information regarding suspension of service out of context can have a detrimental impact on a provider's current business. The fact that services have been suspended in the past does not mean that the current service is poor.
