  - Scrap metal, textiles, wood, fluorescent tubes, CRTs, Fridges/freezers, SDAs and LDAs, hazardous waste, waste oil and cooking oil are collected by suppliers and transported to the disposal locations. The remaining materials are transported by the operators on site to the disposal locations i.e. garden waste, rubble, paper/glass/cans, cardboard, general household waste, landfill waste.
- 9- Approximate annual value of the contract for operating each site (excluding disposal costs / revenues from sales)
  We cannot provide you with two separate figures for each site as the contract forms part of the whole contract value. Therefore, the current annual contract value is £17.7 million.
