Planning Applications

Request:

I would like to request information under FOIA about planning applications where the applicant is an overseas company.

By 'overseas company' I mean any body corporate either legally incorporated in a foreign country or registered to or providing an address in a foreign country.

I would be especially interested in this information in respect of the three calendar years from January 2012 up until the date my request was lodged. However, I will be grateful for the requested information in respect of a narrower time frame if this would help to make release of the information more manageable for you within cost/time restrictions.

1) Please can you advise me how and where information is stored about applicants for planning permission, in particular the names of any IT databases or paper-based filing systems used and how they can be filtered or searched to reveal applications where the applicant is an overseas company? Following careful consideration, the information you requested concerning where information is stored falls under the exemption(s) in section 21 of the Freedom of Information Act 2000 ("The Act"), which relates to 'information reasonably accessible to the applicant by other means'.

The exemption applies as the information is published and publicly-available to view by accessing http://www.wolverhampton.gov.uk/planningapplications

Please note the detail of whether an applicant is from oversees or not is not readily recorded in our systems. However, we have provided below a table (which is not an exact list as the details are not recorded therefore there may be more applications than those provided) which were found using an MS Access query set up to find matches with the various countries provided.
