Free Swimming Terms & Conditions

Free swimming cards entitles an individual to swim free of charge at either Bert Williams Leisure Centre, Central Baths or Wolverhampton Swimming and Fitness Centre during any advertised public session for juniors.

Applicants must fall within the qualifying age groups namely:

• 8 - 16's Residents

Use of Free Swim Card

The card may only be used by the person to whom it is issued.

The card must be produced at reception in order to gain access.

Cards remain valid for the term of the scheme (until 31.03.2015) or until the cardholder's 17th birthday whichever is sooner.

The Free Swim Card may only be used in the pre-advertised public swimming sessions and is not accepted for instruction sessions.

Admissions

Parents/Guardians should be aware that the Safe Swimming Policy applies as follows:

All children under the age of 8 should be accompanied by a person deemed responsible by the management of a centre as detailed below:

- A person aged 18 may be responsible for up to two persons under the age of 8.
 *During pre-advertised family swimming sessions, this person may be responsible for up to three persons under the age of 8.
- Children under 8 years of age must be supervised by a parent/adult 18 years or over in the pool and changing areas.
- Residents of Wolverhampton are those whose parents / guardians pay Council Tax to Wolverhampton City Council.

Further details on the safe swimming policy and the general

admission policy are available upon request from each centre.

Suspension of Use

Any person discovered to have gained a Free Swimming Card on the basis of false or deliberately misleading information may have their card revoked.

The Council reserves the right to refuse admission or to terminate a cardholder's activity/session in the event of behaviour determined by the facility to be unacceptable.
