Reduce Outdoor Events programme to 1 or 2 combined community/business events a year that will attract sponsorship. This means that more expensive existing events would either not be continued or significantly down scaled, unless alternative funding (e.g. health funding, charges, sponsorship and grants) was made available. From 2015 start to sell event management services through a BC Events Community Interest Company or equivalent (income generated will contribute to Civic Halls savings plan).
